TERMS AND CONDITIONS:

- NewGen Trade Schools accepts students into plumbing or electrical course from the age of 15, turning 16 years within the first quarter of the course. This course is for 15- to 21-year-olds.
- Students must have completed IGCSE 1, Grade 9, or an equivalent qualification and/or be 15 years old to apply for this course.
- All fees are payable in advance. The enrolment fee is paid on registration. Monthly school fees are to be received by the school on or before first (1st) of each month.
- EFT payments can be made on a monthly, termly or annual basis on prior arrangement with an early settlement discount.
- Fees received after the 1st of each month will be subject to a late penalty fee of R500 per month and interest on outstanding balances will be charged at Prime + 2%, per month. Should fees be outstanding in full or part for one or more months the child/children may be suspended from school. Fees increase 6% per annum. Should fees be outstanding in full or part for two or more months the outstanding account may be handed over to debt recovery attorneys.
- Fees exclude calculators, IT devices, workshops, uniforms (school), career advisement assessments, if applicable.
- Course registration confirmation will be given upon receipt of the Non-refundable enrolment fee.
- Three months' notice, in writing, is required before removing your child/children from the school, or payment in lieu thereof will be required. Note: if you withdraw your child within the first twelve (12) months of the course, you will be liable for the full twelve (12) months' fees.
- All NewGen Trade Schools students are required to bring their own device. The device's administration rights are required to be signed over to the school for management purposes. Devices are brought to school at own risk.
- Under no circumstances will a student be allowed access to their certificate(s) until such time as all outstanding fees and other due amounts under this contract are paid in full and all assessments completed. Certificates will only be issued to the registered student.
- NewGen Trade Schools and its affiliated companies do not guarantee employment.
